A notwithstanding letter from our former president to a client I'm thinking of you, Jack, and hoping you are back in we helped! Rep could never know what action soon. Bar and I send warmest regards Jack and Mr. Bush experienced in World War II, nor the camaraderie they shared

while serving our country. It was a great example of letter writing from a legendary figure who changed history, was renowned as a great American, and was a respected person on both sides of the political aisle. Mr. Bush certainly had a way with words in his concise, personal, and witty letter to Jack.

Jack passed away in November 2017, leaving Mr. Bush as the sole surviving member of



Ahoy, Matey! For more than a century, the legendary pirate José Gaspar (Gasparilla), has invaded Tampa Bay every year, kicking off two treasure-filled months of parades, festivals, and other excitement. For this year's festivities, or any other, make Accounting/ Administrative Assistant Alicia Farber's 7 Layer Dip for your crew—it's an absolute vegetarian treasure! Arr! (Serves 64)

- 1 (12 oz) package frozen veggie crumbles (e.g. Morningstar, Gardein or Boca)
- ▶ 1 can (16 oz) vegetarian refried beans
- ▶ 1 container (16 oz) sour cream
- 1 package taco seasoning mix
- ► 1 package (8 oz) shredded Mexican cheese
- ► 1 cup prepared guacamole
- ► 1 cup shredded lettuce
- ► 1 cup chopped tomatoes
- ► ½ cup sliced green onions
- ► ½ cup sliced black olives
- ► Tostitos Scoops tortilla chips

Mix veggie crumbles and taco seasoning packet. Heat in lightly oiled pan. Spread refried beans in shallow serving dish. Spread crumbles over refried beans. Top with layers of lettuce, tomatoes, sour cream, cheese and guacamole. Garnish with black olives and sliced green onions. Serve with salsa and scoop chips.
