What is probate?

Ashleigh's Pineapple Salsa

Thank you to marketing coordinator Ashleigh Fisichella for sharing her fun and fresh pineapple salsa recipe with us. This colorful appetizer will be a hit at any party, not just on Cinco de Mayo. It's a little sweet, a little spicy, and 100% yummy. According to Ashleigh, "this quick and easy salsa also goes well with tacos and fish."

- 1 medium red onion, diced
- 5 tomatoes on the vine, diced
- 4 jalapeños, diced, seeds and ribs removed, then minced (adjust for your heat preference)
- 1 fresh pineapple, diced
- 1/2 cup cilantro leaves, chopped
- 2 tbsp fresh lime juice

Place diced onion, tomato, jalapeños, pineapple, and cilantro in a bowl. Stir in the lime juice. Serve immediately or cover and refrigerate. Suggestions for serving: with tortilla chips alongside guacamole or traditional red salsa, on tacos, fish, lettuce as a dressing, or with any Mexican-themed meal.

Pro Tip: In a hurry? Buy pre-cut fresh pineapple from the produce department and dice it up yourself. It's more expensive this way, but quicker.
